

# EpicVerse Open Gaming License (OGL)

---

Version 1.0

## 1. Introduction

This Open Gaming License ("OGL") applies to the EpicVerse rule system developed by Geeky Pat Games L.L.C., hereafter referred to as "the System." This OGL allows anyone to use, modify, and distribute the System as part of their own creative works, provided they adhere to the terms and conditions outlined below.

## 2. Grant of License

GeekyPatGames grants you a perpetual, worldwide, non-exclusive, royalty-free license to use, reproduce, modify, and distribute the System under the following conditions:

## 3. Ownership of Derivative Works

- Any creative content you develop using the System, including but not limited to settings, characters, stories, adventures, artwork, and modifications to the System (hereafter "Derivative Works"), is entirely your property. You retain full ownership rights to your Derivative Works.

## 4. Restrictions

- You may not sell, license, or otherwise distribute the EpicVerse rule system itself, either in part or in full, as a standalone product or as part of any other product.
- You may distribute your Derivative Works that incorporate the System, provided that:
  - You do not claim ownership of the System or any portion of it.
  - You include a clear and prominent notice in your Derivative Works stating that the EpicVerse rule system is used under this OGL and is the property of Geeky Pat Games L.L.C..
  - You include a copy of this OGL with any distribution of your Derivative Works that incorporates the System.
  - You include the full text of this OGL in your work, ensuring it is easily accessible to anyone using or reviewing your work.

## 5. Attribution

- You must include the following attribution in any Derivative Works that incorporate the System:

"This work is based on the EpicVerse rule system, which is licensed under the EpicVerse Open Gaming License (OGL) by GeekyPatGames. The EpicVerse rule system is the property of GeekyPatGames and is used with permission."

## 6. No Endorsement

- You may not imply or state that your Derivative Works are endorsed, sponsored, or affiliated with GeekyPatGames, unless you have received explicit written permission from GeekyPatGames.

#### 7. Termination

- GeekyPatGames reserves the right to terminate this OGL in the event that you violate its terms. In such a case, you must immediately cease all use, distribution, and modification of the System, though your ownership of any existing Derivative Works remains unaffected.

#### 8. Disclaimer of Warranty

- The System is provided "as is," without any warranties or guarantees of any kind. GeekyPatGames disclaims any and all liability for damages arising from the use or misuse of the System.

#### 9. Governing Law

- This OGL is governed by and construed in accordance with the laws of the State of Arizona, USA, without regard to its conflict of law principles. Any disputes arising under or related to this OGL shall be resolved exclusively in the courts of Pima County, Arizona.

#### 10. Entire Agreement

- This OGL constitutes the entire agreement between you and GeekyPatGames concerning the use of the System. No modifications or amendments to this OGL shall be valid unless made in writing and signed by an authorized representative of GeekyPatGames.
